WRAFT's current objective is to compile a large list of property owners who would be willing to have their name & story used, if/when needed, when lobbying the Province for change. If you are willing, WRAFT would like to know;

- your taxes & assessments for the past few years
- a brief history of your cottage –how long owned, family ties etc.
- if you might be contemplating selling because of increased taxes

MPAC - Market Value Assessment - WRAFT

You will have noted Crawford McIntyre's references to taxation issues in his President's comments. There has been an on-going flurry of comments and initiatives over the

last few months in Ontario. By now, all lake property owners have received their interim tax notice for 2006 and are fully aware of the financial impact of the new assessment model. The

Township of South Frontenac is still in the budget process, although to be fair, they only control about half of the mill rate they use to generate taxes. The education levy and the County of Frontenac levy are handed down to the Township for collection.

The BLA has taken the position that we will try to keep the membership current on the taxation topic and also to communicate with other lake associations in our area.
