## President's Message

## Official Plan Review, South Frontenac Township

South Frontenac Township's Official Plan is regarded as one of the most environmentally enlightened of the municipal OPs in Ontario. In accordance with Provincial regulation, it is now under review, a process we have been watching closely since the fall. Prior to Christmas all seemed well when the Councilors came to a consensus on recommendations by the Planning Department that confirmed the thrust of the OP and, in some respects, strengthened those provisions that concern us most, i.e., those related to protection of the environment and especially of the quality of our lakes and groundwater. A public meeting was held to review the proposed revisions and we anticipated the next step would be for Council this spring to approve formally the up-dated OP.

But a few weeks ago, some Councilors appear to have had a change of heart. They proposed two key

changes to the previously agreed-upon recommendations of the Planning Department:

## **Ron's Home & Cottage Services**

- Plumbing, electrical, tiling, window replacement
- Bathroom renovations, flooring of all types, general maintenance
- Closing cottages for winter/water supply & drain systems & spring re-opening
- Renovations of all types

- "Re-setting the clock" to 2008 a provision that in 2000 allowed up to three severances from then-vacant lots without the requirement for those severances to go through subdivision planning or comparable scrutiny to safeguard the environment. The previous consensus was that the "clock" should not be re-set.
- Allowing "back-lot" development (lots without water access) on private lanes. The previous consensus was that such development should not be allowed.

Our view, communicated vigorously to the Mayor and Councilors, was that these two proposed changes:

- 1. Contradict the central thrust of the Official Plan, which is to ensure that the Township's development be done in ways that safeguard the environment, including especially the lakes that constitute one of its principal assets
- 2. Have the potential to increase substantially risks to the environment, especially to the groundwater and to those lakes and waterways already at or near the limit of their ability to sustain further residential development
- 3. Should not go forward to Council without providing the opportunity for additional public scrutiny and commentary

The volume and tone of our communications and those of other Lake Associations (one of which took the form of an on-line petition) has had the effect of postponing further discussion by Council, pending analysis of the public feedback by the Planning Department. The issue, of course, is how best to accomplish two desirable and, in our view, completely compatible goals:

- To foster healthy development through the accommodation of people who want to live, vacation, do business, and farm here and
- To preserve and enhance the very environment that is the Township's greatest asset

The present Official Plan is perceived by some to be a primary obstacle to all development. Sadly, so are Lake Associations and their members! Commenting on the feedback he had received, one Councilor put it 'everybody who has e-mailed me seems opposed to anybody else getting access to the same lifestyle they enjoy' – accusing objectors of having a "dog-in-the-manger" attitude. That may be true of some but it certainly does not apply to those of us trying to represent the best interests of Buck Lakers. I think we would all be happy to share with others the pleasures we derive from living and vacationing on Buck Lake provided that in doing so we can ensure that we sustain and enhance the quality of the lake, groundwater and environment that are the very source of those pleasures. The BLA's mission statement (above) says it all!

This is an issue still very much alive. It requires us all to remain vigilant. Stay tuned! We will do our very best to keep you all closely informed.

# **Lake Planning 2008**

Our lake planning project will be introduced to the membership officially at the AGM on July 5<sup>th</sup>. This will be a great opportunity for everyone who is interested in the health and beauty of Buck Lake to get



involved. This year's objective will consist of collecting data on various flora and fauna around the lake: some possibilities include birds, mammals, fish, insects, invasive plants, turtles etc.

Gord worked on the Bobs and Crow Lake Stewardship Plan and is currently working on plans for Fourteen Island and Mink Lakes. He is a South Frontenac resident as well.

A training workshop for those interested in doing some hands-on data collection over the summer is planned for July 17<sup>th</sup>. We plan to have a number of

#### **Community Policing**

Eight years ago, in the early years of South Frontenac as a new amalgamated municipality, a Community Liaison Program was established within the policing mandate of the OPP. BLA member Ron Mattey was centrally involved in convincing the Township Council to fund the program and in helping establish Community Watch Programs throughout our part of South Frontenac. Tom Varga and George Hiles respectively have fulfilled the role of Community Liaison Officer over these past eight years. With such a large area to police and both seasonal and permanent residents, the program provided a coordinated communications link between the community and the police. Over the years, Buck Lake Community Watch has provided hundreds of information alerts to the Buck Lake community and liaised quickly and efficiently with the OPP through the Community Liaison Officer. George Hiles has been a great resource to the BLA in providing Boater Certification Programs as well as the weekly Incident Reports from the Frontenac OPP.

During February 2008 budget discussions the South Frontenac Police Services Board recommended to Council that the program not be funded for the new five year contract with the OPP commencing May 1<sup>st</sup> 2008. In spite of the efforts of many to convince Council otherwise, the recommendation was supported at Council and the program was not funded in the new contract. We have lost a critical link between the

community and our police which means we must re-double our participation and support for Ron Mattey and the Buck Lake Community Watch Program. We have extended an invitation to Ron to work more closely with the BLA and rely on our continuing support for the program. ## **Tax Time Again**

Another property tax year has begun and we have all made our interim payment at the end of March. South Frontenac has passed its 2008 Budget in the last two weeks and increases are in a range from a small reduction in Storrington District to a 4.6% increase for Bedford District. We are told that an increasing number of services and levies will be standardized across the Township next year but amalgamation seems to have more chapters than "War and Peace". The March Provincial Budget made some announcements about the Municipal Property Assessment Corporation and the current freeze on



reassessment in Ontario. New legislation is promised to place the burden of proof on MPAC rather than the property owner when an assessment is appealed. The Budget also announced an increased property-tax grant for lower income seniors in an attempt to help them keep their homes as long as possible. Government and MPAC officials are working on ways to share more information with taxpayers and make the appeal process more "streamlined and transparent". The new legislation is supposed to be in place for the 2009 taxation year.

- The water levels in the lake were very high this spring and navigating the lake in the spring presents some seasonal challenges. Dangerous rocks and shoals should be less of a risk but many are already marked by the special lake angels who ask no thanks or recognition. Deadheads...floating debris from a long winter are quite common this time of year so keep a close watch over your bow. The culvert had a hard winter and erosion is very evident on the north side. As the water returns to normal levels there could be problems with the water depth at the mouth of the culvert. Please be careful and report any problems through the email box so we can contact the Township. We know that a few propellers got a rough ride last fall when the water levels were lowered so the channel may need a clean out before the water levels get too low.
