President's Message

Unhappily there is a cloud on the horizon in the form of South Frontenac Township's review of its Official Plan, a seemingly never-ending saga on which we are going to have to keep close track. Briefly, some members of Council are trying to change fundamentally the draft OP presented to the public last November, the central thrust of which was to preserve the rural character of the Township. They want to reverse the Planning Department's recommendations to prohibit the development of "back lots" (those without waterfront access) on private lanes and to restrict severances to three on parcels of land vacant when the OP was adopted in September 2005. Simply put, these changes would open the door to more relatively indiscriminate residential construction throughout the Township. This is opposite to the current OP's approach (and the advice of the Planning Department) which is to foster growth primarily through regulated subdivision-type development around the existing population centres. We had thought (hoped) that this issue would be settled by now but it now seems likely that it will be well on into June or perhaps July before we have another public meeting and a final decision by Council. Stay tuned. This is important to us all!

The Board met on May 17th, 2008 and received reports from officers and committees:

- President Duncan Sinclair reported on the Township's progress toward review of the Official Plan and consultation with other lake associations... More detail will follow under separate heading.
- Secretary-Treasurer Trisha Waldron presented a financial report as of May 15th showing current revenues of \$3,308.09 and expenses of \$1,560.83 for year to date. Total members equity including general, reserve and investment accounts stands at \$9,310.30.
- Ralph Wirsig reported on behalf of

Membership Services and Communications. Ninety-three membership renewals for 2008 have been received as well as 3 new memberships. Sixty-eight memberships from 2007 have not been renewed as of May 1st. There will be a membership table at the AGM for those who wish to renew at that time. Ralph also reported that a new advertiser has been added to our newsletter/website efforts and that ad revenue for 2008 is currently \$900.

• Maxine Lemieux reported for the Outreach/Social Committee. Our Buck Lake Pot Luck/Picnic will be hosted by Margaret Fisher on Kingfisher Lane on June 12th (rain date June 19th). Email

notices will be forwarded to all members immediately. The Annual Summer BBQ/Pork Roast is planned for Saturday August 23rd with more details to be confirmed for future newsletters. Maxine has ordered 150 copies of the revised boating regulations booklets and hopes to have them available for the AGM.

• Wayne Myles presented the Terms of Reference for the Lake Planning Committee and after discussion and minor amendment they were approved by the Board. The Board has budgeted \$2000 for Lake Planning in the 2008 budget. The board authorized the Committee to enter into discussions with Mr. Gord Rodgers, a lake- planning consultant who resides in Frontenac, regarding engaging his services during the planning period.



• Stephen Roughton reported on behalf of the Constitution and Archives Committee and presented a draft agreement with Queen's Archives regarding the storage of BLA documents. The agreement was approved. Stephen also presented the report of the Nominating Committee and indicated that

all of the incumbent Directors whose two- year terms will expire in July 2008 have agreed to stand

for another term at the AGM. The slate is complete but additional nominations will be accepted from the floor of the AGM as required. Stephen will forward the Board approved Constitution and By-law amendments to the Communications Committee for inclusion in the June Newsletter as a Notice of Motion for consideration by the membership at the AGM.

 Mr. Peter Dawson, Superintendent of Frontenac Provincial Park joined the meeting at 10:30 a.m. A wide-ranging discussion involved the current programs and initiatives at the Park as well as strategies to improve

Official Plan Review

The saga of the South Frontenac Official Plan review continues. We anticipated that the Council would make some decisions on May 27th but action was deferred until the meeting of June 17th. A group of Councilors are making a concerted effort to make two important amendments to the current Plan...permitting back lot development on private roads and re-setting the three- lot severance restriction once more in an amended Plan. The Planning Department of the Township has advised against these amendments and points out that the goals, objectives and intent of the Official Plan do not envision these critical amendments and the Plan would require wholesale changes to accommodate them. There are significant special interests wishing to see the continuance of the old style random development which the Official Plan attempts to control and direct toward designated growth areas in the Township. Department notes in the May 27th report to Council, of the 14,605 lots that exist in the Township, approximately 2,360 are still vacant.

The BLA was an active supporter of the development and implementation of the current Official Plan and along with virtually all of the current lake associations of South Frontenac is very concerned that our Council may vote to make one or both of these critical changes in the Official Plan. We urge all members to contact their District Councilors and Mayor Davison and caution them about the significance of their vote over the next few weeks. We are watching with interest and concern. If possible, plan to attend the Council meeting in Sydenham on June 17th at 7:00 p.m. It is particularly important that those members
