

**Minutes of the Buck Lake Association**  
**Annual General Meeting**  
**Tuesday September 15, 2020**  
**19:00 – 20:00**  
**Virtual meeting via Zoom**

**1. Welcome**

President Crawford MacIntyre called the meeting to order and welcomed everyone to our very first virtual Annual General Meeting. He explained that our meeting did not take place during the summer as it normally does, due to the on-going COVID-19 pandemic.

**2. South Frontenac Township Government Officials:**

Crawford explained that despite the government officials having been invited to the meeting, they were unable to attend due to their own Council meeting took place at the same time as this one. However, Mayor Vandewal, Councillor Ross Sutherland (Loughborough District), Councillor Randy Ruttan (Loughborough District), Councillor Alan Revill (Bedford District) and Pat Barr (Bedford District) provided their written comments to Crawford who read them to the audience.

**3. Remarks by President - Crawford MacIntyre**

- South Frontenac Lake Ecosystem Advisory Committee created
  - Result of the efforts of Greg Fisher and Randy Ruttan
  - Buck Lake Board member, Gillian Lash, was selected to participate on committee
- Boatilla
  - Raises funds for Camp Merrywood which is run by Easter Seals
  - Has always been independent of the Buck Lake Association
  - Crawford has identified a couple of candidates who may want to help drive Boatilla
  - Despite Boatilla not taking place, close to \$9500 was raised for Camp Merrywood from Buck Lake residents
- Rider Cup

- Annual golf event which has been renamed to Buck Lake Rider Cup
- New leadership of Peter Dawe and Dean Milner
- Did not take place this year, but will resume in 2021
- Monday morning golf
  - Organized by Bruce McDonald
  - Occurs throughout the summer culminating in the challenge of the North and South branches
- Newsletter
  - Relevant articles written by Board members as well as Buck Lake members
- Buck Lake Facebook page
  - Number of members increased substantially during the pandemic
  - Close to 700 members
  - Used to share photos, comments, resources
  - Easy way to communicate

- Jim Manuel Volunteer Award
  - Crawford gave some background about the naming of the award
  - Duncan Sinclair's extensive involvement in many aspects of the Buck Lake community (BLA, BBQ, buoys on lake, numerous newsletter articles, Boatilla committee, etc.) makes him this year's recipient

#### 4. Treasurer's Report – Greg Fisher

##### Revenues:

- You will notice that we are not providing a Statement of Income or budget for 2021
  - COVID-19 impact on operations was significant and made substantially reduced our ability to forecast for 2021
- Membership is down to 116 families in 2019 from 220 in 2018
- Number of advertisers decreased to 6 in 2019 from 8 in 2018
  - Due to COVID-19, we thought that we would help our local advertisers by putting a moratorium in place for advertising fees in the newsletter
- Calendars were in high demand with Cheryl having to place a second order

##### Expenditures:

- Insurance covers Board members and Buck Lake members during member events
- Affiliate membership includes our membership to the Federation of Cottage Associations (FOCA)
- Meeting costs include AGM, Education Night and for a Director to attend the annual FOCA meeting in Toronto
- Lake planning includes supplies and shoal markers

##### Balance Sheet

- Assets
  - Cash in bank \$7,490
- Liabilities
  - Raised for Boatilla \$1,800

- Equity \$5,860

#### **5. Membership – Greg Fisher**

- Have noticed a 10% decline in memberships over the last 3 years
- Of 450 eligible households, currently only 25% (116) are members
  - Despite our newsletter being sent to more households
- With a larger membership, our voice is stronger
- We ask the audience to encourage others to join and show their commitment to the community

#### **6. Social and Outreach – Ria Berry**

- Unfortunately Murder Mystery (in support of Camp Merrywood) and the annual picnic were canceled due to the pandemic
- Winterfest gathering is being planned for early 2021

#### **7. Friends of the Lake (FOTL) – Martha Scheinman**

- We hope that Education Night will return in-person in 2021
  - Input on relevant topics is welcomed
- FOTL is a resource for environmental topics such Gypsy Moths, shoreline rehabilitation, etc.
- Another great resource (and free to Buck Lake members) is the Federation of Cottage Associations (FOCA)
  - We encourage to subscribe to their newsletter
- We are always looking for new members who are interested in and have a passion for environmental issues

#### **8. Nominating Committee – Crawford MacIntyre**

- Board members are nominated for a 2-year period for a maximum of 6 consecutive years
- Maximum 12 Directors
- Directors for re-election include Crawford MacIntyre, Cathy Ottenhof, Randy Rattan and Cheryl Savery
- Unfortunately, we are losing Greg Fisher and would like to thank him for his 6 years of service
  - Along with Mel and Duncan leaving
- The following new members are being nominated for the three openings
  - John Curran
  - Don Young
  - Nora Lapp
- No other nominees were brought forward by the audience
- No objections were voiced

#### **9. Other Business and Open Question Period**

- John Curran mentioned that with the low water levels, the public boat ramp is in need of repairs and asked for assistance
  - Crawford MacIntyre replied that he will connect with one of the Township engineers
- Rob McLean reiterated that not all Buck Lake members are on Facebook, so how can those people receive relevant information
  - Cheryl Savery responded that the most relevant information to all Buck Lake members is relayed via the newsletter

## Appendix C

### Buck Lake Association 2019 Treasurer's Report Annual Meeting September 15, 2020

#### Budget Revenues

- Revenue reduced due to moratorium on advertising; and no murder mystery night in support of the Boatilla due to Covid-19. To early to project budget for 2021 as events dependent on status of community with respect to Covid-19

#### Revenues:

- Membership revenues decreased marginally from prior year (approx. 116 families in 2019 vs 122 families in 2018) (continues trend slight decrease 2017 - 129)
- Deferred revenue ("DR") represents memberships paid in advance and can vary significantly from year to year. DR in 2019 represents \$1,275 towards 2020; \$100 – 2021
- In 2019 we had 6 advertisers for our newsletter and website down from 8 the prior year. The revised budget for 2020 shows 0 revenue. Due to covid-19 and the impact it was having on our community and our businesses – it was decided to place a moratorium on advertising costs on 2020 in support of our business community – advertisers remain in our newsletter. This will be revisited for 2021.
- Community – In 2018 the murder mystery night was run entirely by the BLA, the Westport legion hosted the event and was paid for the dinner they provided. In prior years this had been a joint event. \$4,032 represented the proceeds from the murder mystery night tickets and silent auction (in support of the Boatilla). With the 2018 figures, \$1,300 of the income represented a portion of the BLA share of proceeds from 2017 received from the Legion in 2018. Actual 2018 revenue was \$5,272
- Donations in 2019 were \$85.00. Most of these are donations made when members have paid their fees online with FOCA. Prior to our use of FOCA as a payment vehicle – donations were minimal
- Other represents the charges FOCA makes for using them to collect our membership fees (currently 4.5%). In 2019 offsetting the FOCA expense was postage recovered from calendar recipients and foreign exchange adjustments

#### Budget Expenditures

- Again, reflect impact of Covid-19 – no 2020 picnic, murder mystery or hall rental for AGM. Effectively offsets change in revenue

## Expenditures:

- Insurance represents our liability insurance related to both the Board and for BLA sponsored events.
- Affiliate membership represents our membership cost for Federation of Ontario Cottagers' Association ("FOCA") (currently \$125 plus \$3.25 per member)
- Administrative fees is our Post Office Box rental; some postage costs
- Cost of 2019 calendars – increase from 2018 based on calendars sold
- Meeting costs generally represent annual meeting & education night costs. In 2019 support for attendance at FOCA mtg \$294; cost of Jim Manual award \$102 included in community in 2018
- Social & outreach in 2019 and 2018 represents the cost of the picnic;
- In 2019 Community Included the following (2018 amounts in brackets):
  - Picnic table \$0 (\$800)
  - Murder mystery expenses; Jim Manual award/ welcome baskets \$31.95; (199.35)
  - Murder Mystery direct expenses (meal and entertainment) netted against income \$2,232.5 (2,680.00)
  - Education night \$0 (2017 - \$28.24)
  - Remembrance Day ceremony \$75.00 (\$75.00)
  - Boatilla \$1,800 (1,201.43 related to 2017 and 2464.06 related to 2018)
- Lake Planning - \$113.02 (\$50 education night hall rental \$63.02 Shoal marker supplies)- (\$70 was hall rental for education night and 225.93 were supplies for shoal markers) (2017 – 300)
